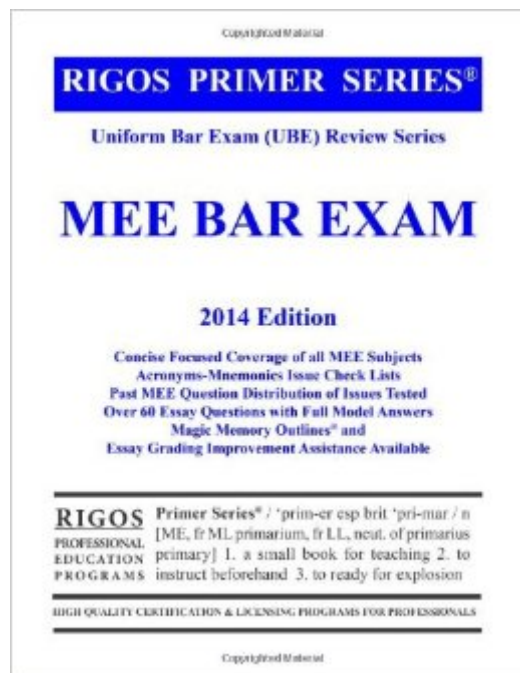

The Rigos MEE Bar Exam program is excellent. I successfully passed two bar exams on the first sitting using Rigos. Rigos excels in several areas, areas where its competitors fail to provide students with key tools to ensure passage. One area I found very helpful was the prior bar exam distribution charts. Knowing what has been tested, and the frequency of such issues, helped me to focus on key subjects. By spending more time on subjects heavily tested, I prepared to ensure I knew these key subjects inside and out. These distribution charts eliminate the anxiety of trying to master the entire potential universe of testing subjects. Further, Rigos places these issues into levels of importance, essentially providing students with a concise roadmap of issues. A second area where Rigos excels is in the boilerplate language for major issues. Instead of fretting over crafting a response during the exam, Rigos provides language to memorize.
